

To qualify for the two-year eco-healthy endorsement:

- The child care facility must comply with at least 30 of 35 items including #2, #8, #17, #18, and #19 which are required.
- One staff member from the child care facility must **successfully complete the** <u>Protecting Children's Environmental Health E-Course</u>. The course is offered in English and Spanish on the ProSolutions platform and has been approved for adult learning clock hours.

All EHCC checklist items comply with <u>Caring for Our Children: National Health and</u> <u>Safety Performance Standards</u>, online database.

# **Quality Control**

#### Fees

The 2-year endorsement processing fee:

- Facilities licensed to care for 1-20 children = \$25
- Facilities licensed to care for 21+ children = \$50

# **Renewal Discount**

Facilities that submit for renewed endorsement before their current one expires will receive a \$10 refund of their endorsement fee once a submitted application is reviewed and processed.

# Eco-Healthy Child Care® Endorsement Program

Upon meeting the criteria outlined in the checklist, including a non-employee witness name and contact information, completing the self-paced Children's Environmental Health Protection e-course (\$30 for a 3-hour session), and submitting the \$25/\$50 endorsement fee, your facility will receive the 2-year Eco-Healthy Child Care® certificate of approval and monthly Eco-Healthy Hot Tip emails.
